### TERMS AND CONDITIONS OF PERSONAL PROPERTY MOVEMENT

1. The borrower shall:
  - a. return the item(s) in like condition as received from Jefferson Lab, normal wear and tear excepted, and free of contamination, on or before the expiration date, unless the temporary personal property movement period is formally extended or is terminated before the due date;
  - b. in case of loss or damage of the property, reimburse JSA/Jefferson Lab at the current price of replacement or repair;
  - c. assume all costs involved in preparation, handling, disconnecting, and transportation from and to JSA/Jefferson Lab;
  - d. agree to indemnify and hold harmless the JSA/Jefferson Lab and the Department of Energy against any and all liability, loss, damages, claims and costs incidental hereto as a result of Borrower's use or possession of the property; and
  - e. use JSA/Jefferson Lab property only for the purposes specified in this temporary personal property movement agreement
2. The above property shall not be modified, loaned, or transferred to a third party without the written permission of JSA/Jefferson Lab
3. The Borrower shall account for, or permit inspection of, the property by JSA/Jefferson Lab after proper notification.
4. This is United States Government Property. Title to the property is vested in and will remain with the United States and the property shall be used only for official purposes. The Lender reserves the right to cancel the temporary person property movement or to recall the property upon 30 days notice.
